

Welcome Missouri S&T Student and Parent,

We would like to take this time to introduce some of the medical services at S&T.

The Student Health Complex is located at 910 W. 10th Street, across from Allgood-Bailey Stadium. Please see our website for our patient care hours. It is preferred that students schedule appointments, but walk-in appointments are available for acute illness. We do not replace your current primary care provider but can assist in care while your student is on the S&T campus. Our professional staff includes but is not limited to: a physician, a physician assistant, two nurse practitioners, two LPNs, and two medical assistants.

Our Services

Primary services are offered at no charge. There are reduced-cost fees for laboratory tests, x-rays, and medications. These can be paid at the time of service or charged to the student account. In most cases, our service is less than the copay at a primary care office. For example, most antibiotics are \$5; most labs are \$5 - \$15; and x-rays are available at a reduced rate.

Insurance

Student Health does not bill insurance for general services; however, we suggest that students have a copy of their insurance cared (front and back) should it be needed for an emergency or for an outside provider. We can use insurance for laboratory testing completed through Quest and for immunizations through VaxCare. Our insurance coordinator can be available to assist with this process.

Electronic Health Records

All medical records are electronic and comply with privacy standards. Students are required to log into the patient portal (<u>mst.studenthealthportal.com</u>) with their student ID and password. Upload proof of immunizations here and complete the following required forms:

- Tuberculosis Screening Form
- Privacy Statement
- Healthy History
- Consent to Treat a Minor Form (only for students under the age of 18)

Health Requirements

Students living in campus housing are required to be vaccinated for <u>Meningitis after age 16</u>. All students taking classes on campus are required to have current <u>2 MMR vaccines after age 1</u>. All students are required to complete a tuberculosis risk assessment form. Students will need to log in to the patient portal (<u>mst.studenthealthportal.com</u>) to complete the required forms and upload immunization records. Holds will be placed on registration for the subsequent semester if these are not completed.

Special Medical Needs

For students that have special medical needs, please contact us <u>prior</u> to arrival on campus.

ADHD

Student Health providers DO NOT diagnose ADHD; however, we are able to provide treatment on an individual basis and assist in making the best decisions regarding the academic and social impacts of ADHD. Consultations for ADHD treatment require an appointment with a physician.

Mental Health

For students that have a specific mental health need, it may be wise to discuss these prior to arrival on campus. S&T offers a brief treatment model for common mental health concerns such as stress, anxiety, and depression. Limited psychiatric services are available in the area. Student Health providers offer limited ability to manage mental health medications. Allergy Injections

Students that require allergy injections will need to present to the health center with their serum and complete a Request and Consent for Administration of Allergy Immunotherapy. Injections will be coordinated with the prescribing allergist. There is a \$45/semester admin fee. Students can store allergy serum at Student Health but should pick it up during extended breaks. Student Athletes

If your student is a varsity athlete, there will be an on-campus complete medical evaluation required prior to the start of practice or competition. Contact your coach for details on the time and location. Complete the required forms on the electronic health record PORTAL prior to arrival to campus. Student-athletes cannot be cleared until these are completed.
